Included is a letter from Ms. Hefner, CEO of Playboy re-emphasizing their position. Kappa cannot afford to be involved in any type of litigation regarding this issue. **Please, if you are using the Playboy Bunny in any way, discontinue its use immediately.**


Over the past months, I understand that our legal counsel has been in touch with you regarding what is, quite frankly, the rampant trademark infringement of Playboy's trademarks by the Kappa Alpha Psi fraternity and its local chapters. While I appreciate the fact that you have members who are fans, I'm sure you appreciate the fact that we cannot tolerate the pervasive infringement of Playboy's valuable intellectual property rights by the fraternity.

In previous correspondence, you have assured Playboy's legal counsel that Kappa Alpha Psi would direct its chapters to cease infringement of Playboy's trademarks since as you have acknowledged, "Kappa Alpha Psi ... has no right to any perfected or registered intellectual property rights of Playboy." I need your assistance in putting an immediate end to this situation as numerous chapters persist in their intentional and willful infringement of the RABBIT HEAD DESIGN and PLAYBOY marks to promote the fraternity and its goods and services. The current infringement includes use on active chapter websites, tickets to events, posters, banners, clothing, and a variety of other fraternity paraphernalia. Thus, it is clear that appropriate steps have not been taken to cease this infringement.

I would much prefer to avoid the expense and embarrassment to the fraternity of litigation, but to do so, Kappa Alpha Psi must immediately adopt a compliance program to effectively and expeditiously resolve this matter.
